C., one Year's advertisement fee as additional fee alongwith regular advertisment fees should be recovered as is done in case of cases under section 394 and 313 of B.M.C. Act.

Sub: Charging of one year's fee as ertisement fee in cases where pt starts displaying advertisements before valid permission.

Date

Ref:- This office's circular No. SL/: of 91-92 (SL/5737/LAD of 5-9-91).

As per the above referred circular, he year's fee as additional advertisement fee is to be recovered in case's where the display of advertisements is started by the parties without obtaining valid permission.

Recently, one such case of display of advertisement hoardings in railway premises was referred to this office wherein party has disputed the payment of advertisement fees.

The matter was, therefore, referred to D.M.C.(Zone-V) and as per D.M.C.(Zone-V)'s orders under No. MDE/614/AORE of 4-6-1992, the above circular regarding charging of one year's fee as additional fee will not be sade applicable to the approved railway sites and BEST sites. Since the permission given in such cases is for a shorter period and the applicant cannot wait till permission from B.M.C. is obtained as their rentals with authorities start immediately from the date of allotment. However, the applicant party will have to make the payment along with the application itself or within 10 days from the date of application and ward staff will accept the same on the spot. Inspection and verification wto, will be done later on by the staff.

However, ix if the fees are not paid within 10 days from the date of application, composition at the rate of 25% shall be charged. This applies to the existing approved railway/BEST sites only.
