PART-2

TERMS AND CONDITIONS FOR VIDEO CINEMAS

1. Video Cinema is not located in purely Residential Zone.
2. In case of Video Cinema located in Residential Zone with shipline the same is in an independent authorized ground floor structure with front open space of not less than 7.5 mtrs. and side and rear marginal open spaces of not less than 7.6 mtrs. In other zones minimum marginal open space of 6 mtr. is provided all round bldg.
3. The site for Video Cinema is within the distance of 30 mts. (100') from the nearest boundary of the recognized school or a Hospital with beds of not less than 50 or temple or other religions places or reservation for school/hospital provided in the Development Plan of Brihanmumbai.
4. If more than one Video Cinema is is located in the same premises then separation distance of at least 15 mtr. shall be insisted upon between two Video Cinemas.
5. The place where the Video Cinema is intended to be displayed is having a separate enclosed space either detached or semi-detached on ground floor with no residence on upper floors.

6. If the premises is having non-residential users only, the Video Cinema is in a separate enclosed space on ground floor.
7. The place where the Video Cinema is intended to be exhibited is not having an area less than 40 sq.mt. Video Cinema is permitted only on the ground floor.
8. Not more than 30 persons are allowed in such enclosed space, if the enclosed space is bigger than the minimum area prescribed above then additional persons at the rate of 1 person per sq.m. is allowed subject to maximum number of 75 persons.
9. One third of the area of the premises used for Video Cinema is separated and made available as waiting lobby. This is in addition to the area of 40 M for 30 persons etc. as specified in Rule No. (2) above.
10. The premises used for exhibiting Video Cinema is air-conditioned.
11. The distance between television screen or any other screen used for exhibition of Video Cinema and the front row of the seats is not be less than 1.80 mts.
12. The Television set used for exhibition through the Video cassettes recorder, video cassettes player or any other similar instrument is kept on an

elevated fixed platform so as to be visible to the viewers sitting in the last row.

13.The minimum clear height of the room to be used for Video Cinema is not less than 3 Mts.

14.The size of the television screen or screen used for any other media is not less than 51 cms.

15.Chairs with folding seats are provided in the enclosed space, they are fixed with the floor. Sufficient space is kept between two rows of seats and the said space is not less than 30 cms in width.

16.The enclosed space is well ventilated by providing adequate number of ceiling fans, exhaust fans or installing air conditioner.

17.There is separate exist and entrance for enclosed space of Video Cinema.

18.Separate toilet facilities for gents and ladies are provided as per the provisions of the draft Building Byelaws and Development Control Rules.

19.The sufficient parking spaces as per the provisions of the Development Control Rules for assembly building is provided.

20.The Video Cinema will not be exhibited earlier than 10 AM and will not be exhibited after 11.30 PM

21.The size of the exhibition board or any other placard is as per the rules prescribed by the Supdt. of Licence of respective zone in which the site of such Video Cinema is situated.

22.Other necessary licences will be required under the provisions of other Central or State Laws.

23.Necessary licence for exhibition board etc. is obtained from the Supdt. of Licence under the relevant provisions of the Mumbai Municipal Corporation Act.
