APPEAL

By directions of Hon'ble Supreme Court, the Construction and Demolition Waste (C&D Waste) and debris generated from developmental activities in Mumbai are to be scientifically disposed of by the developers. Maharashtra Chamber of Housing Industry (MCHI), the apex body of the Housing Construction Industry has approached MCGM for identifying and approving new sites for accommodating the C&D Waste / Debris generated within Mumbai.

MCGM therefore request the land owner / POA / Authorized Representative to come forward to allow low lying plots and similar lands to private developers. Contractors and other agencies to unload / fill their plots with construction & demolition waste. The approval as C&D site will be given on compliance of following.

- 1) The applicant should apply with clear title certificate & Property card / 7 x 12 extract.
- 2) Local authority / statutory permission as applicable for filling & levelling to be obtained by the applicant.
- 3) Contour map (to assess filling capacity) of plot.
- 4) No financial remuneration will be given by MCGM.
- 5) The format of application to be filled.
- 6) The transporter / approved site owner shall be required to comply with Construction and Demolition Waste Rules, 2016 as promulgated by Government of India.
- 7) Other detailed conditions as displayed on MCGM website portal.mcgm.gov.in.

Subject : Approval as Authorised Agency for Segregation of Waste, Processing of Wet Waste and Recycling of Dry Waste from Housing Societies, BWG (Bulk Waste Generator) Societies, Commercial establishments, Hotels, etc. within MCGM jurisdiction.

PUBLIC NOTICE

MCGM has taken a policy decision to provide 15% rebate in general tax of Property Tax to housing societies, for segregation of waste (5%), processing of wet waste (5%) and recycling of Grey Water or Rain Water Harvesting (5%).

The rebate shall also be applicable to societies who dispose of their waste on their own in their premises or through some agency at the location other than their residential premises in scientific manner. However, the agencies appointed by the societies shall need to be authorized / approved by MCGM.

Applications are invited from eligible & willing firms for the subject matter.

Eligibility criteria for Agency to obtain authorisation is as under :

- Agency should be registered with GOI / GOM/ ULB, Charity Commissioner, etc.
- The agency shall have experience of at least 01 years in the field of segregation & processing of waste.
- Agency's Office & processing / segregation plant should be in Mumbai Metropolitan Region.
- Agency should have its own set up plant, facility of minimum 500 Sq.Ft area for Storage, Segregation and Processing / Composting of Wet Waste in MMR region or should have an agreement with the landowner. This area shall be proportionately adequate for the quantum of waste to be processed.
- Agency should have tie up with Authorised Re-cycler for disposal of segregated Dry Waste.
- Agency should have tie up with farmer's co-operatives, Fertiliser Companies, Nurseries for use of the compost.
- Agency should have required permissions / NOCs from statutory bodies, if applicable, for processing of waste.

This is to inform that the Solid Waste Management Department of MCGM has devised a **web based application – My Waste** for data collection purposes. The application is accessible at the link as under:

This application captures society's basic garbage generation information. The information can be filled periodically by the Chairman / Secretary / Manager or the housekeeping staff appointed by the society for garbage management. Registration on the application is a onetime process wherein society's SAC number and mobile number of the representative of the society is required. A step by step guide to registration and thereafter data filling is available on MCGM's website as under:

It is also to be informed that in order to avail rebate in the General Tax component of Property Tax, it is mandatory to register and duly update data in '**My Waste**' application.
