Notes:

- 1) Minimum 50 PAP tenements shall be handed over to MCGM from each project. About 1000 PAPs are expected in each administrative zone.
- 2) The Carpet area of the PAP tenement to be handed over to MCGM shall be minimum 27.88 sq.mt.
- 3) To developer will be entitled to get TDR / FSI as applicable and available as per DCPR-2034.
- 4) Developer may quote the premium over and above the TDR/FSI available as per DCPR-2034.
- 5) MCGM will select the Expression of Interest which will be overall beneficial to MCGM in terms of net cost to MCGM per tenement in that administrative zone.
- 6) MCGM shall not pay premium, if any, in terms of money. But shall give credit note in the form of IOU of the amount of premium to be paid by the MCGM. The IOU will be transferable from one person or legal entity to other and can be used for paying municipal dues, taxes and making all municipal payments only for payee.
- 7) The TDR for Scheme under 3.11. of regulation 33(10) of DCPR 2034 and FSI for scheme under regulation 33(20)B for construction of PAP tenements for MCGM as well as the premium amount quoted if any for the project, will be released in stages as mentioned in Tender documents.
- 8) MCGM will accept/ reject the Expression of Interest in each zone which will be beneficial in terms of net cost per tenement to MCGM which will be calculated by dividing total premium quoted by total number of PAPs surrendered to MCGM in lieu of TDR plus Premium Amount quoted by the developer
- 9) MCGM reserves rights to accept or reject the other EOI received in the same Zone.
- 10) MCGM reserves the rights to reject any or all the Expression of Interest without assigning any reasons thereof.
- 11) The specification for construction of PAP tenements / buildings to be handed over to MCGM shall be as per the Tender document.
- 12) The validity period for acceptance of the EOI will be 180 days, which may be extended for further period of 180 days with consent of the developer.
- 13) The specification for construction of PAP tenements / building to be handed over to MCGM will be available in the office of Assistant Commissioner (Estates) department 4th floor, annex bldg, MCGM Head office, Fort Mumbai– 400001.
