Terms & Conditions

- 1. As per assigned days services to be provided from 8:00 am to 4:00 pm and also for emergency.
- 2. The equipment's and medicines required by the anesthetist for the purpose of inducing anesthesia upon the patients who are to be operated upon at the hospital will be provided by the hospital
- 3. The Anesthetist shall check the equipment provided by the hospital before inducing anesthesia upon the patients who are to be operated upon, at the hospital.
- 4. Anesthetist shall be solely responsible for all the clinical acts and complications of what so ever nature in the matter of inducing of anesthesia upon the patients who are to be operated upon at the said hospital.
- 5. The anesthetist will perform anesthesia checkup, induce anesthesia and carry out post anesthesia checkup of patients to the satisfaction of the CMO of the hospital.
- 6. Anesthetist shall maintain necessary medical records of the patients to the satisfaction of the CMO of the hospital.
- 7. Operation theatre list will be informed by the resident medical officer one day prior.
- 8. During their tenure of services no Leave is applicable.
- 9. Payment of the anesthesia charges will be as per Standing Committee Resolution no. 2264. Payment will be done after submission of the bill by the appointed anesthetist.
- 10. Anesthetist agree that claims that may arise in respect of clinical acts & complications of what so ever nature in the matter of inducing of anesthesia by the anesthetist at the said hospital and in this regard the anesthetist shall execute and submit an indemnity bond with the Chief Medical Officer of the hospital which indemnity bond shall indemnify the BMC safe and harmless against any claims that may arise in respect of the clinical acts and complications of what so ever nature in the matter of inducing of anesthesia by the anesthetist upon the patients who are to be operated upon at the said hospital.
- 11. Anesthetist appointed shall not be deemed to be employees of the BMC or that of the said hospital and further that the Municipal Service Regulation, Provident Fund & the Pension Rules of the BMC applicable to the regular employees of the BMC shall not be applicable, and cannot go in the Court of Law for this.
- 12. Anesthetist appointed will have to submit a undertaking of terms and conditions on Stamp Paper.
- 13. Appointed Anesthetist performance if found NOT SATISFACTORY, their services will be terminated.
- 14. Disputes in any in the matter of interpretations of the terms & conditions shall be referred to Municipal Commissioner of the Corporation whose decision shall be final and binding.
