Successful bidder will have to operate the Pay & Park Scheme by providing infrastructure facility at their own cost and by engaging their own staff and meeting other expenses etc. and to recover charges from the vehicle owner/driver as per rates approved by the Municipal Corporation with the help of Web based automated device known as '**Hand Held Electronic Device**'. The cost of hand held electronic devices along with necessary software and hardware will be bear by parking agency itself.
