Note:

- 1. All applicable taxes shall be considered before quoting the rates for the tender
- 2. The tenderer should quote the tender as per GCC contract
- 3. The GCC contract will be applicable to successful bidder & same is available on the MCGM website i.e. portal.mcgm.gov.in
- 4. Security Deposit:- The successful bidder will have to pay security deposit @2% of total contract price as security deposit for faithful performance of the contract. Such contract deposit shall be either in the form of Demand draft or tenderer shall pay such contract deposit online & same shall be refunded on successful completion of the work. However the contractor shall have to submit bankers Guarantee (BG) of equivalent amount valid for a period of one year against which the contract deposit shall be refunded.

In case of rebate of more than 12% of the office estimate, however such contract deposit shall be refunded after a period of 1 year after completion of work. It is however necessary to issue a certificate before refunding the contract deposit in such cases that the quality of the work carried out is up to the mark & no defects have been observed during this period.

- 5. The successful tenderer should submit the affidavit on Rs. 500/- stamp paper stating that they will submit valid insurance policy i.e. work contract policy, CAR policy in due course of time.
- 6. The tenderer quoting rebate of premium more than 15% of the office estimated cost should submit the rate analysis to the office of AE(SWM)M/W within 24 hrs. after opening the bid and if it is not workable then the penalty of Rs. 5000/- each for first 3 instances will be recovered from the vendor's registration deposit or from his dues with MCGM. If continuation of such offences is observed, then the action of blacklisting the vendor shall be initiated by concerned ward.
- 7. If successful tenderer do not submit the requisite documents like, authorization certificate, Experience certificate, Performance Gurantee, affidavit etc. within three days, the offer of L-1 will be cancelled. Further their security deposit will be forfeited & will be debbared for next 3 years and offer of L-2 bidder will be accepted.

8. Additional Security Deposit:-

The tenderer quoting the rebate more than 12% of the office estimate shall have to pay ASD for the entire amount calculated as per the formula given below without any maximum limit.

Where X= percentage rebate quoted on the office estimated cost by the tenderer minus 12%

9. Refund of ASD:-
