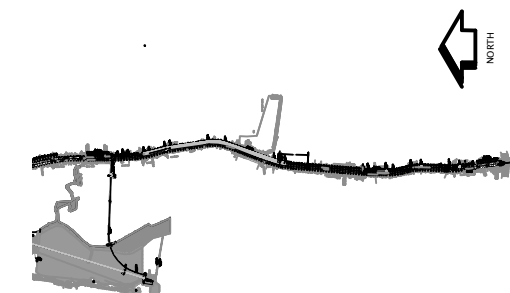


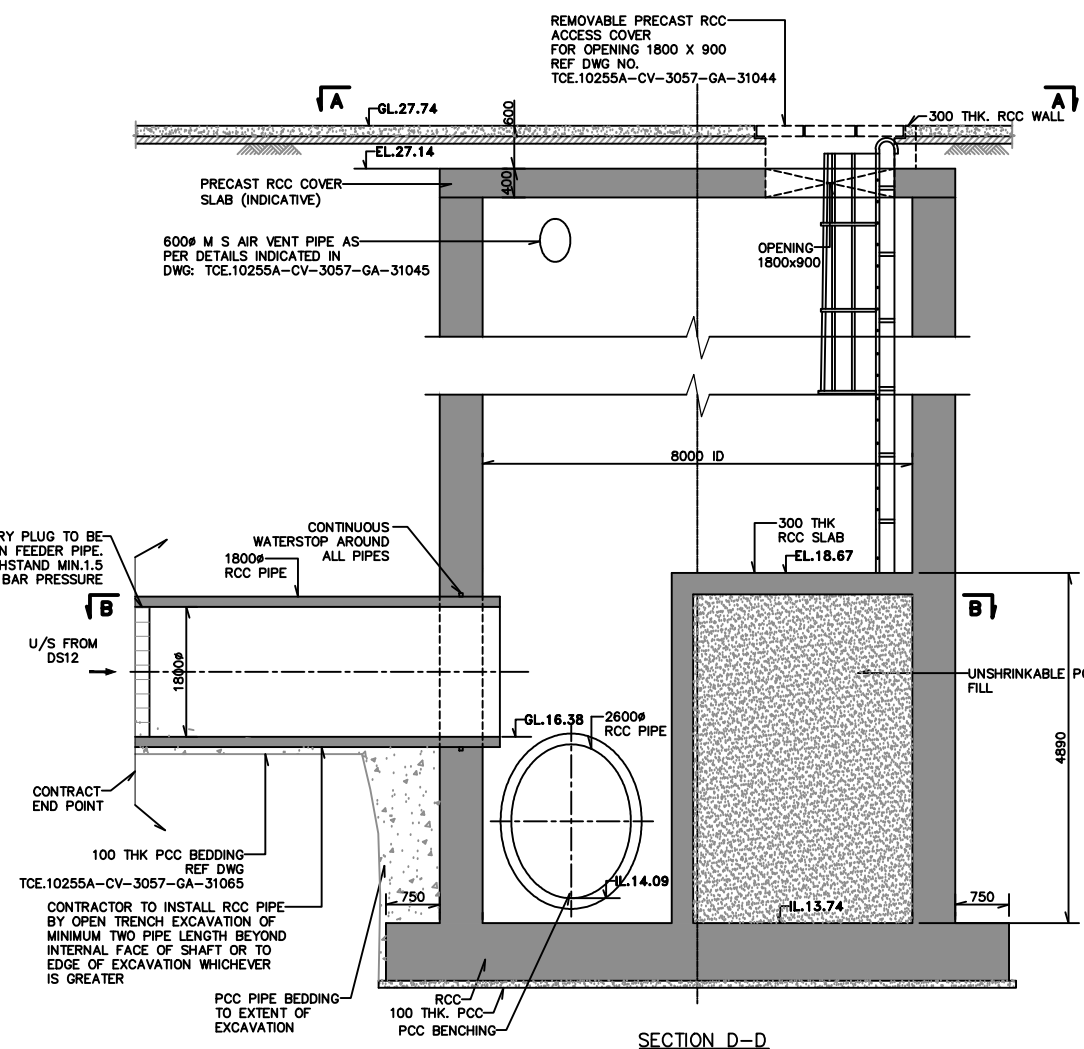
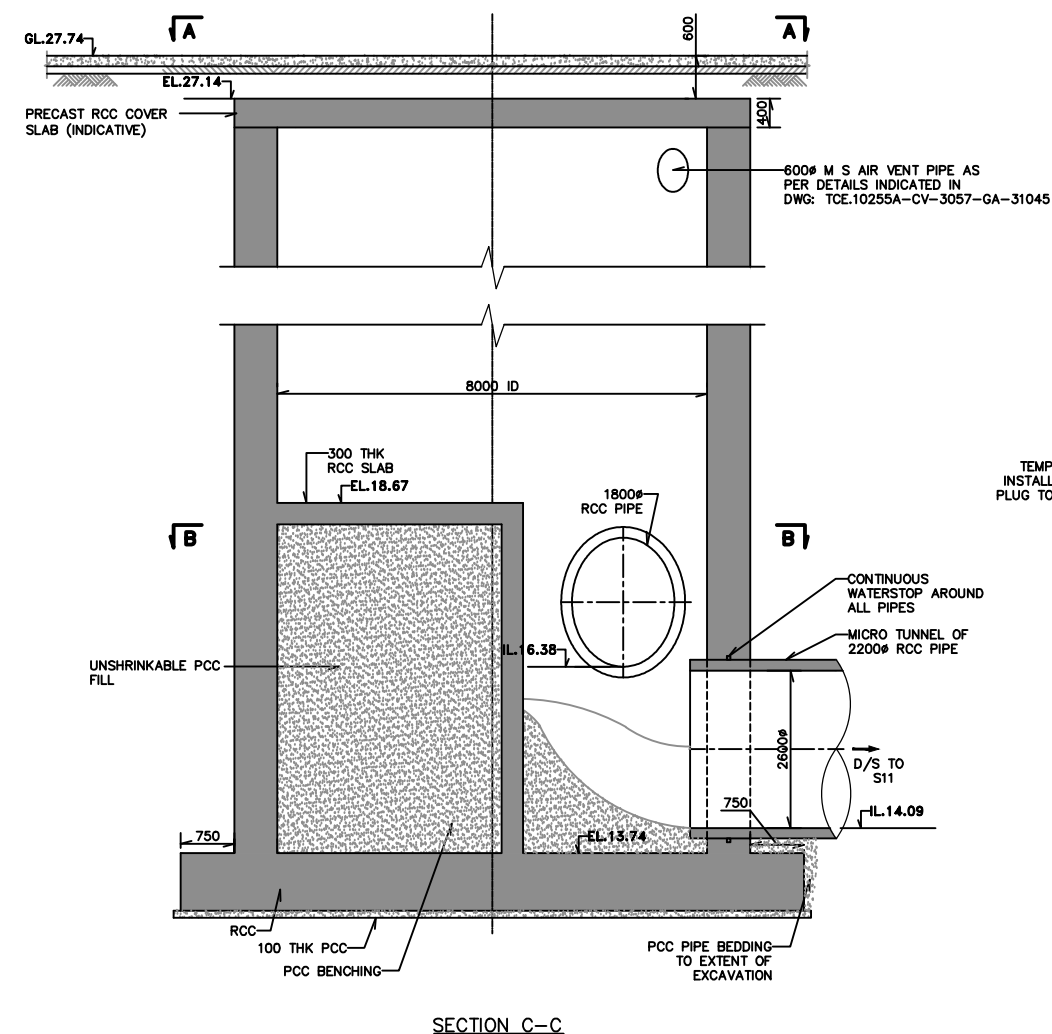
TIME PRIORITY SEWER TUNNEL - PHASE 2 (PST II)
