The BRIHANMUMBAI MUNICIPAL CORPORATION (BMC) invites e-tender on **Item Rate / Percentage Rate** Basis to appoint Contractor for the aforementioned work from **Manufacturers / Authorized dealers who are dealing with such type work**. The contractors who are not registered with MCGM will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. **E.M.D** (Earnest Money Deposit) **will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty**.

Bidding Process will comprise of THREE stages.

The application form can be downloaded from MCGM's portal (<http://portal.mcg.gov.in>) on payment of **Rs 1,800/- plus GST @ 18 % = Rs 2,124/-**. The applicants not registered with MCGM are mandated to get registered (Vendor Registration) with MCGM for e-tendering process & obtain login credentials to participate in the online bidding process.

To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, Municipal Headquarter.

Followed by SRM login ID and password to be obtained from Central Purchase Department (CPD), Office at Bakariadda, Opp. 'S' Bridge, Byculla (W), Mumbai – 400 011

For e-Tendering registration, enrollment for digital signature certificates and user manual, please refer to respective links provided in 'Tenders' tab. Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics center, TCS, CUSTOMS, MTNL, GNFC and e- Mudra CA.

In terms of the 3 stage system of e-tendering, a Bidder will be required to deposit, along with its Bid, an **Earnest Money Deposit of Rs 33,000/- (Rupees Thirty Three Thousand only)** (the "EMD"), refundable in accordance to the relevant clause of bid document, from the Bid Due Date, except in the case of the selected Bidder whose Bid Security/EMD shall be retained. The Bidders will have to provide Earnest Money Deposit through the payment gateways while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit. The e-tender is available on MCGM portal (<http://portal.mcg.gov.in>) as mentioned in the Header Data of the tender.

As per THREE Packet systems, the document for Packet A & B is to be uploaded by the bidder in vendor's document online in Packet A, B. The Packet A, B & C shall be opened on dates as mentioned in header data. All the responsive and eligible bidders if they so wish can be present at the time of opening of bids, in the **office of Assistant Engineer (Maint.) Water Work Eastern Suburb-I**. The Packet C shall be opened if bids submission in Packet A & B satisfies/includes all the requirements and same are found acceptable to the Authority.

The Municipal Commissioner reserves the right to reject all or any of the e- tender(s) without assigning any reasons at any stage.

(iii) The bidder shall be **Manufacturer and or an Authorized Dealer** of the Manufacturer S.S.304 collar. If tenderer is authorised dealer then he shall produce authorisation certificate from Manufacturer on Manufacturer's Letter head.

(iv) Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which tenders are invited should be either of the following

a) **Three similar completed works each** of value not less than **Rs 4.90 Lakhs**

OR

b) **Two similar completed works each** of value not less than **Rs 5.70 Lakhs**

OR

c) **One similar completed work** of value equal and or not less than **Rs 8.10 Lakhs**

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.
