Subject:- Repair, overhauling, servicing of two wash water pumps, four booster pumps, two PAC dosing pumps and overhauling of agitator motors & extension of shaft & blades of agitators at Tulsi Water Treatment Plant, Bhandup Complex.

The Brihanmumbai Municipal Corporation (BMC) invites e-tender on item rate basis to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public i.e.eminent Limited Companies/Companies registered under the Indian companies' act 2013, The contractors registered with the Brihanmumbai Municipal Corporation, (BMC) in Class C category as per old registration 2015 or 'Class C' as per new registration 2016 or firms dealing in the line and from the contractors/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

Bidding Process will comprise of THREE stages.

The application form can be downloaded from e-procurement system of Government of Maharashtra (Mahatenders) (https://mahatenders.gov.in).

The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process of Government of Maharashtra (Mahatenders) (https://mahatenders.gov.in) Interested bidders should have valid Class III digital signature certificate (DSC) obtained from any licensed certifying authority. Interested bidders should follow the manuals available on Mahatenders Portal (https://mahatenders.gov.in). Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics center, TCS, CUSTOMS, MTNL, GNFC and e- Mudhra, CA.

As per circular no CA/FRG/18 Dt-27.02.2024, scutiny fee amount is Rs.660 + 18% GST and same shall be recovered from bidder after opening of packet A & B and before opening of packet C in any of the Citizens Facilitation Center (CFC) at 24 wards wards & major hospitals in city, on week days except Saturday & Sunday. Tenderer shall obtain challan from the Office of Dy. Hydraulic Engineer, (Bhandup complex) for making the payment of tender scrutiny fees at any of the CFCs.

The Bidders will have to provide Earnest Money Deposit through the payment gateways while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit.
