E-TENDER NOTICE

Sub: “Shifting and Up-gradation work of establishment and store room under Executive Engineer (Transport) Eastern Sub-urban at Pantnagar Garage Building.”

The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contractor for the afore mentioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under Indian companies’ Act 2013. The contractors registered with the Brihanmumbai Municipal Corporation, (BMC) in appropriate Class as per old registration and Class as per new registration and from the contractors/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months’ time period from the award of contract, otherwise their Bid Security i.e. E.M.D(Earnest Money Deposit)shall be forfeited/recovered and an amount equal to Registration Fee of respective class shall be recovered as penalty. Bidding Process will comprise of THREE stages.

The scrutiny fee of Rs.15,000/- + 18% GST as mentioned in header data shall be paid through challan in BMC’s CFCs and follow guidelines as per Circular no. CA/FRG/03 dt 11.05.2023. The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process of Government of Maharashtra (Mahatenders)
