- (i) The bidder shall be **Manufacturer and or an Authorized Dealer** of the Manufacturer of maintenance tools i.e. H.S.S.Tap & Drill, Pipe Wrench & Pressure Guage. If tenderer is authorized dealer then he shall produce authorisation certificate from Manufacturer on Manufacturer's Letter head in the format given in annexure-G (Pg.161).

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

For assessing the technical capacity of Regular, Routine and Maintenance works; ("Similar work" shall mean, the completed supply of various maintenance tools in BMC / Semi Govt / Govt. & Public Sector Organizations during last Seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor.

<u>1.2 Financial Capacity</u> :

Achieved an average annual financial turnover as certified by "Chartered Accountant" equal to **Rs 7.70 Lakhs** of work in **last three (3) financial years (i.e. 2021-22, 2022-23 & 2023-24)** immediately preceding the Financial Year in which bids are invited.
