**Sub: Work of supply & installation of M.S. safety grating on SWD at 90 MLD Vihar water treatment plant under AEOC(TM) division.**

The Brihanmumbai Municipal Corporation (BMC) invites e-tender on Percentage Rate basis to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the firm registered with Brihanmumbai Municipal Corporation new rules of registration 2016 in Class-B in M&E category or from the contractors / firms equivalent and superior classes registered in Govt. organization carrying out similar nature of works (excluding those are blacklisted, demoted and debarred in BMC,,PWD, other Govt./semi-Govt. organization in India). The contractors who are not registered with BMC will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be entirely forfeited / recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

### **Bidding Process will comprise of THREE stages.**

The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.
