Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics centre, TCS,CUSTOMS, MTNL, GNFC and e-Mudhra CA.

#### 1.1 Technical Capacity

The tenderer(s) in their own name should have satisfactorily executed the work of similar nature in BMC /Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the date of issue of tender as a prime Contractor.

Bidder shall visit the site to get conversant with the scope of work, site constraint of the proposed work of "Replacement of LED Street Light fitting with allied work at Various Cycle track Under AEOC(TM) division." Site visit report shall be submitted / uploaded with duly sign & stamp by site in-charge / site engineer, as per the BMC format attached as per Annexure G (Pg.no.116) along with packet B, falling which the bidder will be out rightly rejected.

- a) Three similar completed works each of value not less than the value equal to 30% of estimated cost put to tender i.e. 3,09,000/- for each work.(Excluding GST) OR
- b) Two similar completed works each of value not less than the value equal to 35% of estimated cost put to tender i.e. 3,60,000/- for each work. (Excluding GST) OR
- c) One similar completed work of value equal and or not less than the 50% of estimated cost put to tender i.e. 5,14,000/- for each work. (Excluding GST)

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

\*In case of ongoing works to be considered, the bidder must have received payment bills of 80% of the contract sum for the work/works executed last day of previous month to the one in which bids are invited.

### 1.2 Financial Capacity

Achieved a average annual financial turnover as certified by 'Chartered Accountant' equal to 30% of the estimated cost i.e. **Rs. 3,64,000/-** of work in last three (3) financial years immediately preceding the Financial Year in which bids are issued.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

### 1.3 Similar Experience

Similar type of the work should have carried out by bidder such as "repairing of electrical equipments / electrical machines / electrical wiring, rewiring and meter cabin wiring."
