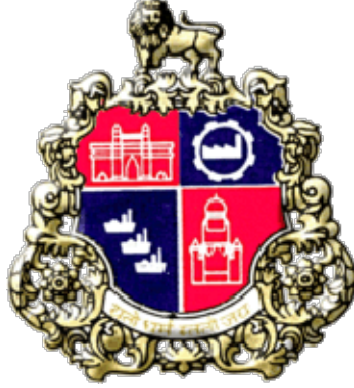

The Commissioner of BRIHANMUMBAI MUNICIPAL CORPORATION (BMC) invites e-quotation as given below in three Packet systems i.e. Packet –A (Administrative), Packet-B (Technical) & Packet-C (Commercial & Folder “c”) from registered vendors. The E-Quotation copy can be downloaded from Mahatender portal (<https://mahatenders.gov.in>) under e – procurement section after the online payment of scrutiny fee.

Bidders who wish to participate in the Bidding process must register on the website <https://mahatenders.gov.in/nicgep/app>. Bidders, whose registration is valid, may please ignore this step. At the time enrolment, the information required for enrolment should be filled. After enrolment the bidder will get his user name and password to his e-mail ID.

Bidders should have valid Class III Digital Signature Certificate (DSC) obtained from any licensed Certifying Authorities (CA) for registration, enrolment for digital signature certificate and user manual, interested Bidders should follow the respective links provided in Mahatender Portal. (<https://mahatenders.gov.in>)

All interested vendors, are required to be registered with BMC. Vendors not registered with BMC before, can apply online by clicking the link ‘Vendor Registration’ under the ‘eprocurement’ section of BMC Portal, Vendor already registered with BMC need to contact helpdesk to extend their vendor registration.

The pre-bid meeting will be held **on 22.07.2025 at 15.00 pm, venue of the same is at CMS & HOD (SHCS) Office, 2nd Floor, K.B. Bhabha Hospital Building, Bandra West, Mumbai 400 055.** The prospective tenderer(s) should submit their suggestions/observations, if any, in writing minimum 2 days before Pre-bid meeting. Only suggestions/observations received in writing will be discussed and clarified in pre-bid meeting and any modification of the tendering documents, which may become necessary as a result of pre-bid meeting, shall be made by BMC exclusively through the issue of an addendum/corrigendum. The tender uploaded shall be read along with any modification. **Authorized representatives of prospective tenderer(s) can attend the said meeting and obtain clarification regarding specifications, works & tender conditions. Authorized representatives should have authorization letter to attend the pre-bid meeting.** The tender document is available on BMC portal (<http://www.BMC.gov.in>) along with this tender notice. However, the tenderer shall have to pay "e-tender price" through online payment gateway before downloading and uploading the tender document in SRM Module.

The tenderer shall have to **pay EMD of Rs. 4,03,600/-** through on line payment only.

Note :-

- **Bidders /Service Provider has to visit at hospital Location to get the clear idea of about nature of the work, different activities, services and their quantum of work to be provided in the hospital premises well before submitting the rates in the item data of Mahatender Portal.**
- **Bidders/Service provider will require to arrange no of manpower to carry out services defined in tender.**
- **Bidders are requested to quote rate as follows.**
 1. **Providing manpower services in the unit per shift per month (i.e. working 8 hours per shift for 365 Days).**
As these services falls under “Pure Services “Hence GST is exempted (As per the Circular no. CA(F)/FRT/31 dated 29.11.2017)

Minimum wages act should be strictly applicable.

The tenderers shall have to pay the tender EMD amount through on line payment. No Exemption will be allowed.

Authority (BMC) shall not be liable for any omission, mistake or error in respect of any of the above or on account of any matter or thing arising out of concerning or relating to the tender or the bidding process, including any error or mistake therein or in any information or data given by the authority.
