# 1.1 Technical Capacity

The tenderer(s) in their own name should have satisfactorily executed the work of similar nature in BMC /Semi Govt. /Govt. & Public Sector Organizations during **last seven (7)** years ending last day of month previous to the date of issue of tender as a prime Contractor.

\*In case of ongoing works to be considered, the bidder must have received payment bills of 80% of the contract sum for the work/works executed last day of previous month to the one in which bids are invited.

#### 1.2 Financial Capacity

Achieved a average annual financial turnover as certified by 'Chartered Accountant' equal to minimum of **Rs. 4,51,900/-** of work in last three (3) financial years immediately preceding the Financial Year in which bids are issued.
