The Brihanmumbai Municipal Corporation (BMC) invites e-tender for the aforementioned supply from contractors of repute, multi disciplinary engineering organizations i.e. eminent firm or Proprietary/Partnership Firms or (Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013) the contractors registered with Brihanmumbai Municipal Corporation, (BMC) will be allowed.

Bidding Process will comprise of THREE stages.

The application form can be downloaded from e-procurement system of government of Maharashtra (<http://mahatenders.gov.in>). The applicants not registered with BMC are mandated to get registered (Vendor Registration) with Mahatender for e-tendering process & obtain login credentials to participate in the online bidding process.

i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, BMC Headquarter.

ii) The forms of tender documents are available on the e-tendering website <http://mahatenders.gov.in>. The aspiring applicants will have to download tender form, from the website mentioned above. The bidder has to fill in online format and upload information regarding tender online. Also he has to download the tender application form from website, fill it and upload the scanned copy of duly filled form, along with required documents.

iii) For purchasing the tender documents, the bidders will have to get registered with e-tender portal (<http://mahatenders.gov.in>) for the e-tendering process and obtain login credentials to participate in the online tender process. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit. Packet A, B & C shall be opened on dates as mentioned in header data. All the responsive and eligible bidders if they so wish can be present at the time of opening of bids, in the office of The Dean, H.B.T. Medical College & Dr. R. N. Cooper Hospital, Juhu, Vile Parle (West), . The Packet C shall be opened if bids submission in Packet A & B satisfies/includes all the requirements and same are found acceptable to the Authority.
