**Qualification / Eligibility Criteria:** The quotationer shall have MCGM vendor registration and shall have carried out minimum one job of testing of pressure vessels / lifting tackles as per Factory Act in MCGM /Semi Govt. /Govt. & Public Sector Organizations during last seven years. The copy of the work order with number, date, contract period & cost of the work or completion certificate shall be annexed by the quotationer while submitting the offer.

**Quotation price payment:** The quotation document shall be purchased from the Office of Dy. Hydraulic Engineer, (Bhandup complex) at the address below on payment of quotation price at any of the Citizens Facilitation Center (CFC) at 24 wards & major hospitals in city, on week days except Saturday & Sunday up to previous day of due date of quotation. No challan will be issued on due date of quotation. The quotationer shall possess BMC vendor registration number for the purchase of quotation. The quotationer not having BMC vendor registration number shall obtain the same from online through BMC portal prior to purchase of quotation.

**Earnest Money Deposit (E.M.D.) payment:**

- 1) The quotationer shall pay the earnest money deposit in cash / P.O. / Demand Draft drawn in favour of BRIHANMUMBAI MUNICIPAL CORPORATION at any of the Citizens Facilitation Center (CFC) at 24 wards & major hospitals in city, on week days except Saturday & Sunday up to due date and time of quotation.
