The copy of the work order with number, date, contract period & cost of the work or completion certificate shall be annexed by the quotationer while submitting the offer.

The e-quotationer shall obtain challan from the office of Dy. Hydraulic Engineer, (Bhandup complex) for making the payment of scrutiny Fees at any of the CFCs.

- 2) The registered Municipal Contractors having standing deposit with BMC shall also have to pay Earnest Money Deposit for this e-quotation.
