The Brihanmumbai Municipal Corporation invites e-quotation on item /percentage rate basis for the **"Rewinding and overhauling of submersible dewatering pumps along with allied works at Pretreator Plant Bhandup Complex"**

Similar Experience: Similar experience means the completed work such as overhauling /repairs to submersible dewatering pumps in BMC / Government organization in last 7 years. The copy of the work order with number, date, contract period & cost of the work with performance certificate shall be annexed by the e-quotationer while uploading the offer.

opened if bids submission in Packet A & B satisfies/includes all the requirements and same are found acceptable to the Authority.
