1. Following documents duly attested by notary / Administrative officer (M.C.G.M.) should be enclosed with e-quotation

  - iii. Authority Letter from the Manufacturing Company / Authorized agent / Distributor should be enclosed (If Applicable).
2. The rates should be stated in figures as well as in words.
3. The offer should be inclusive of all taxes. (i.e. GST / Delivery charges etc) subsequent increases in the price /cost due to any reasons will not be entertained.
4. The undersigned has reserved all rights to reject any offer without assigning any reasons to the Quotationers.
5. The payment will be made within 30 days after receipt of complete supply.
6. Delivery / Penalty :-
