- 1. Following documents duly attested by notary / Administrative officer (M.C.G.M.) should be enclosed with e-quotation

  - iii. Authority Letter from the Manufacturing Company / Authorized agent / Distributor should be enclosed (If Applicable).
- 2. The rates should be stated in figures as well as in words.
