II. PAN Documents of the Co. / Proprietor / Two Directors with Color Photo

3. Bifurcation of taxes should be submitted on letterhead with HSN code along with name of items. (Basic rate should not be disclosed any indication of basic rate will lead to rejection)

4. Supply should be made at Medical Store , Bharatratna Dr.Babasaheb Ambedkar Hospital ,kandivali west in full quantity at once.

5. EMD Should be paid online on or before of the due date & time.
