Technical Specification of ECG Machine 12 Channel

Electrocardiograph should have capability of recording 12-lead ECG in A4 format and should have the following features:

- Should have simultaneous acquisition of 12 Leads
- Should have a display to preview the ECG waveform before printing
- Should have a screen display greater than 5.5 inch and it should be tiltable
- Should be compact, portable and easy to operate
- Should have keyboard for manual entry of patient data
- Should have provision for providing Hospital Name on the printed record
- Should work on Li-ion battery
- Should have a frequency response of 0.05-150 Hz
- Should have sampling frequency of 1000 Hz
- The device should weigh less than 5.5 kgs with battery
- Should have a special arrhythmia triggered mode of printing
- Should have Pacemaker detection facility
- Should be able to record on different modes of sensitivity: 2.5,5,10,20 mm/mV & AGC
- Should have different recording speeds: 12.5, 25 and 50 mm/sec
- Should have different filters available for smoothing of waveform
- Should have AC Filter, EMG Filter: 25 or 35 or 45 Hz or OFF
- Should have Anti-Drift Filters
- Should have different print formats: 3/6/12, 3x4 with rhythm leads, 6x2, 12x1
- Should have a large storage of 500 ECGS
- Should be able transfer data directly in PDF format to USB
- Should have different modes of saving data: DAT/PDF
- Should be able to printout records on thermal paper as well 2-Foid
- Should have facility of printing in automatic/ manual/ rhythm/R-R mode of printing
- Should have facility for interpretations and measurements
- Should provide detailed printout of patient data
- Should have paper of minimum width of 210mm
- Should have the capability to generate any number of ECG Copies for distribution
- Should be able to connect to PC
- Should be able to operate to a maximum of 4 Hours on a newly charged battery
- Should have direct external printer connectivity
