Post Qualification Criteria

To qualify for the award of contract, each bidder should fulfill the following criteria:

1. **Financial Criteria:**

The quotationer shall have an average minimum turnover of not less than Rs. 6, 00,000/- during the last three financial years i.e. 2022-23, 2023-24 & 2024-25

(Submit attested copies of audited balance sheets or a turnover certificate issued by a Chartered Accountant.)

2. **Technical Criteria:**

The quotationer must have experience in the supply of the specified materials, with a single work order of not less than Rs. 1, 20,000/- in any one year during the last three financial years i.e. 2022-23, 2023-24 & 2024-25. (Submit attested copies of work completion certificates issued by a competent authority.)

Quotation forms will be issued only after producing an experience certificate or Purchase order copies of the similar/same item.

Earnest Money Deposit (EMD):

An EMD of Rs. 6,000/- must be paid in cash/online or by Bank Draft only.
