Post Qualifying Criteria :-

The quotationer shall have executed work of similar nature i.e. housekeeping and cleaning of office premises, bathrooms, toilets, ceilings & walls, floorings in any Govt. / Semi Govt. / Municipal body in India in last three years. The quotationer shall submit the Purchase Order along with completion certificate with their offer, failing to which the offer of that quotationer shall be treated as non-responsive.

Quotation Document :-

The blank quotation copies are available in the office of **E.E.Mech.(M.S.)W.S.** at address mentioned below, between 11.00 a.m. to 4.30 p.m. on any working day, except on Saturdays of the month. The Challan for quotation cost shall be obtained from this office and paid at any CFC Centre. A copy of receipt of the payment shall be produced in this office upon which quotation document will be issued. The last date of issue of quotation forms will be up to the day of the due date i.e. 19.09.2022 up to 12.00 noon.

Earnest Money deposit(EMD) :-

The quotationer shall pay E.M.D. of Rs. 2,720/- by way of cash or Demand Draft drawn in favour of Municipal Corporation of Greater Mumbai payable at Mumbai.

The E.M.D. Receipt No. and date shall be clearly mentioned on the envelope.

Only Registered Municipal Suppliers (in case of quotation for supply), having revised Standing Deposit according to their class & category, are exempted from payment of Earnest Money Deposit. However, it is mandatory on the Registered Municipal Suppliers to mention Standing Deposit Receipt No.

on the quotation envelope and also enclose attested photo copy of the Standing Deposit Receipt along with the quotation.
