Post Qualification Criteria: 1. The quotationer shall be registered contractor who shall have successfully executed the “work of rewinding/overhauling/servicing of induction motors of capacity 10 KW or more” in any Municipal Corporation/Semi Govt./Govt. & Public Sector Organizations during last seven (7) years.

The Challan for quotation cost shall be obtained from this office and paid at any CFC Centre. A copy of receipt of the payment shall be produced in this office upon which quotation document will be issued. The last date of issue of quotation forms will be upto the day of the due date, i.e.; on 15/09/2022 upto 12.00 noon.

Earnest Money Deposit (E.M.D.):

The quotationer shall pay E.M.D. of **Rs. 3,000/-** by way of cash or Demand Draft drawn in favour of Municipal Corporation of Greater Mumbai payable at Mumbai.

The E.M.D. Receipt No. and date shall be clearly mentioned on the envelope.

Only Registered Municipal Suppliers (in case of quotation for supply), having revised Standing Deposit according to their class & category, are exempted from payment of Earnest

Money Deposit. However, it is mandatory on the Registered Municipal Suppliers to mention Standing Deposit Receipt No. on the quotation envelope and also enclose attested photo copy of the Standing Deposit Receipt alongwith the quotation.
