### Post Qualification Criteria:-

- 1) The quotationer should have carried out single work of "epoxy painting for equipments at height more than 10 mtrs" similar nature successfully during last seven (7) years in any Municipal Corporation /Semi Govt. /Govt. & Public Sector Organizations. He/ She/ They shall submit documents in the evidence of that.
- 2) If quotationer failed to submit the documentary evidence of above point will be treated as non responsive and 10 % amount of EMD will be forfeited for Non-responsiveness.

Only Registered Municipal Suppliers (In case of supply only), having revised Standing Deposit according to their class & category, are exempted from payment of Earnest Money Deposit. However, it is mandatory on the Registered Municipal Suppliers to mention Standing Deposit Receipt No. on the quotation envelope and also enclose attested photo copy of the Standing Deposit Receipt along with the quotation.
