Post Qualification Criteria:-

Quotationer shall specifically note following post qualification criteria towards technical eligibility

1. The quotationer should have carried out work of Repairs of Control Panels in any Municipal corporation /Semi Govt./Govt. & Public Sector Organizations during last 7(seven) years prior from the date of invitation of quotations. As documentary evidence, “performance certificate” shall be submitted.
2. The quotationer should have valid Electrical Contractor License registered with Maharashtra state.

Note:-If quotationers fail to submit the documentary evidence of above, the quotationer will be treated as Non-responsive and 10% amount of EMD will be forfeited for Non-responsiveness.

Quotation Document:

The blank quotation copies are available in the office of Ex.Eng.Mech.(Sew.)E.S at address mentioned below, between 11.00 a.m.to 5.30p.m.on any working day, except all Saturday of the month. The Challan for quotation cost shall be obtained from this office and paid at any CFC Centre. A copy of receipt of the payment shall be produced in this office upon which quotation document will be issued. The last date of issue of quotation forms will be up to the day of the due date i.e. 11 .10 .2022 up to 12.00 noon.

Earnest Money deposit (EMD):

The quotationer shall pay E.M.D. of **Rs.3000/-** by way of cash or Demand Draft drawn in favour of Municipal Corporation of Greater Mumbai payable at Mumbai.

The E.M.D. Receipt No. and date shall be clearly mentioned on the envelope.

Only Registered Municipal Suppliers, having revised Standing Deposit according to their class & category, are exempted from payment of Earnest Money Deposit. However, it is mandatory on the Registered Municipal Suppliers to mention Standing Deposit Receipt No. on the quotation envelope and also enclose attested photo copy of the Standing Deposit Receipt along with the quotation.
