Quotationer shall be firms dealing in this line and shall have previous experience in similar works in B.M.C. /Semi Govt. /Govt. & Public Sector Organizations.

The last date of issue of quotation forms will be up to the day of the due date i.e. 14.11.2022 up to 12.00 noon.

The quotationer shall pay E.M.D. of **Rs. 2200/-** by way of cash or Demand Draft drawn in favour of Municipal Corporation of Greater Mumbai payable at Mumbai. The E.M.D. Receipt No. and date shall be clearly mentioned on the envelope.
