- 1) e-Quotations are invited for the **“Work of replacement of Monoblock Pumpset and laying of PVC Pipeline with allied works at Gorai Refuse Transfer Station.(GRTS)”** as per specifications, terms and conditions of quotation & schedule of quantities.
- 2) The e-Quotation shall be submitted online on or before 04.10.2024 not later than 04.00 p.m. Telegraphic Quotation will not be accepted under any circumstances, ‘A’ and ‘B’ Packets of e-Quotation will be opened on 05.10.2024 after 04.00 p.m.
- 3) The Quotationer shall pay Earnest Money Deposit of Rs 3,000/- online only
- 4) The rates quoted shall be firm and no variation will be allowed subsequently on any account.
- 4) The rates quoted shall be firm and no variation will be allowed subsequently on any account.
- 5) **Tax:**
“G.S.T. and other state levies/cess which are not subsumed under GST will be applicable. The tenderer shall quote inclusive of all taxes. It is clearly understood that BMC will not bear any additional liability towards payment of any Taxes & Duties.
Wherever the services to be provided by the Tenderers, falls under Reverse Charge Mechanism, the Price quoted shall be exclusive of GST, but inclusive of Taxes /Duties/Cess other than GST, if any.
Rates accepted by BMC shall hold good till completion of work and no additional individual claim shall be admissible on account of fluctuations in market rates; increase in taxes/ any other levies/ tolls etc. except that payment / recovery for overall market situation shall be made as per Price Variation.”
- 6) **Contract period: -**
The contract period for subject work is 15 days from the date of receipt of SAP PO / LOA (whichever is earlier).

8) **Validity of the Quotation:-**

The Quotation shall remain firm and valid at-least for **180 days** from the date of it's opening / submission.

9) **Terms of payment:-**

As per the Municipal procedure, the payment of work done will be made within 30 days from the receipt of the bill, subject to verification as per normal rules, in case of supply of any article, the payments will be made within 30 days from the receipt of the bill, subject to satisfactory test of the article including it's installation, if any.

10) The Municipal Commissioner does not bind himself to accept the lowest or any Quotation. In case of any dispute, Municipal Commissioner's decision shall be final and binding on the Quotationers. (The Municipal Commissioner reserves right to split the quantity between two or more quotations)

11) **Guarantee :-**

a) The successful quotationer shall have to furnish a free maintenance guarantee (on the Municipal prescribed form affixed with a special adhesive stamp of Rs.200/- thereon) for 12 calendar months from the date of supply /commissioning or completion of work for any manufacturing defects or faulty workmanship. If any defect is noticed within the guarantee period and intimated to the contractors, they will rectify the same free of cost.

b) The successful Quotationer shall enter into a written contract with BMC in the prescribed form by paying the contract deposit (5% of the contract amount), legal & stationary charges & lump sum levy as applicable.

12. The Quotationer shall not withdraw his offer within the validity period. If he does so, the Earnest Money Deposit paid, will be absolutely forfeited to the Corporation.

13. **Penalty :-** For failure to comply with the order placed for work / supply of the articles within the stipulated period of 15 days from receipt of SAP PO/LOA(whichever earlier), a penalty equivalent to 1/2 % per week or part thereof on the value of the delayed work / supply of articles will be recovered from the contractors without making any reference to the contractors. The amount of the penalty will, however, be subject to the maximum of 10% of the contract sum or such smaller amount as may be fixed by the Chief Engineer (SWM).

14. The Quotationer shall give the undertaking in the sub-joined form.

15. The Quotationer shall invariably submit this Quotation notice form together with the specification, schedule of quantities and rates duly filled in and signed. Any irregularity in this respect may render the quotation liable for rejection.

16. The payment will be made in contractor's or supplier's Account in the bank through ECS system. The contractor/supplier shall, therefore, state the name of bank, branch and account No. on the bill.

17. It is compulsory for the contractor to get themselves registered with BMC as a vendor by payment of appropriate fees & following due procedure.

18. To attach xerox copy of the Registration Certificate under B.S.T. Act, 1959

- 19.** All the Quotations must disclose the names of their partners, if any in the particular contract. Any quotationer failing to do so will render himself liable to have his tender deposit forfeited and the contract, of entered into cancellation at any time during its currency.
- 20. a).** None of the Quotationer whose firms are having common partner / proprietor or who are connected with the another either financially or as principal & agent or master and servant or closely related to each other such as Husband and wife, father / Mother and minor son /daughter and minor Daughter /sister shall quote separately under different names of establishments.
- b)** If it is found that any firm having common partner/proprietor who are connected with one another either financially or as principal and agent or master and servant closely inter-related such as husband and wife, father/mother and minor son/daughter and minor daughter/sister have quoted separately under different names or establishments for the same contract, the Quotation shall stand rejected and Earnest Money Deposit shall be forfeited. Any contract entered into under such condition will also be liable to be cancelled at any time during it's currency. In addition such firms / establishments shall be liable at the direction of the municipal Commissioner for further final action including blacklisting.
- c)** If it is found that closely related persons as in direction no. 20 have submitted separate Quotations under different names of firms / establishments but with common addresses for such firms / establishments and / or if such establishments / firms though they have different addresses are managed or Governed by the same person / persons jointly or separately, such quotationer shall be liable for action on the direction No.21 A including similar action against the firm/ establishments concerned.
- d)** If the award of contract is found that the accepted quotationer violated any of the direction 21A, 21B or 21C the contract shall be liable for cancellation at any time during its currency in addition to penal action against the contractors as well as related firms/ establishments.
- 22.** In the event of any dispute between Brihanmumbai Municipal Corporation i and the contractor the dispute would be subject to the Mumbai jurisdiction only
- 23. A)** Under the Provision of the section 194 (c) of the Indian Income Tax act the corporation is required to deduct tax at source & under present legislation Tax @ 2.2% of the gross amount of each bill submitted shall be deducted at source 7 the certificate for the same will be issued.
- B)** As per recent amendment in Maharastra Sales tax act 1999, the works contract tax amount at the following rates will be deducted at source for the turnover amount exceeding Rs.2 Lakh in financial year which may please be noted. The necessary TDS certificate will be issued at the time of releasing the payments.
