Sub: Circular regarding amendments in a “Rules Governing Registration of Contractors in Civil and Mechanical & Electrical Engineering works — 2016” for the engineers Retired from B.M.C. and Government /Semi Government services on the basis of PWD, Maharashtra

Ref: 1) Hon’ble Municipal Commissioners approval u/no. MGC/F/8881 dated 17.02.2023

As per the Hon’ble Municipal Commissioner’s approval u/no. MGC/F/1614 dated 25.10.2016, the Rules for registration of contractors have been sanctioned under the name “Rules Governing Registration of Contractors for Civil and Mechanical & Electrical engineering works-2016” and the same came in force from 01.12.2016.

The proposal was put up to Hon’ble Municipal Commissioner to make amendments in Rules of Registration-2016 in accordance with the Government of Maharashtra’s public works departments G.R. No.2021/Case no.95/Bldg-II dated 16.11.2021 regarding Registration of Engineers retired Govt./Semi Govt. services as contractors. Now as per the approval of Hon’ble Municipal Commissioner at ref. No. 1, necessary set of rules applicable to the Registration of Engineers retired from B.M.C. and other govt./semi-govt. Services as contractors are incorporated and same are amended in “Rules Governing Registration of contractors for Civil and Mechanical & Electrical Engineering works — 2016”.

**1. The set of rules applicable for Registration of Engineers retired from B.M.C. and other govt./semi-govt. Services as contractors are as follows-:**

- i. As per Municipal Pension Rules- 1953, retired engineer desiring for Registration as a contractor in B.M.C. before the expiry of two years from

date of his retirement should obtain the previous sanction of Hon. Municipal Commissioner.

- ii. Engineers retired from B.M.C. services cannot tender/bid for a period of one year after retirement in the department/zone in which they have worked during the last year of retirement.
- iii. The Engineers who have retired from the post below Executive Engineer shall be given registration as a Civil Contractor having limit to the tune of Rs. 90 lakhs (Civil Discipline Class- IV(A)) and Electrical Engineers up the limit to Rs. 10 lakhs (M&E Discipline Class- C). Relaxation for the registration will be available up to 10 years from the date of registration.
- iv. The Engineers who have retired from the post of Executive Engineer and above shall be given registration as a civil contractor having limit to the tune of Rs.150 lakhs (Civil Discipline Class- IV) and Electrical Engineers shall be given registration having a limit up to Rs. 25 lakhs (M&E Discipline Class- B). Relaxation for the registration will be available up to 10 years from the date of registration.
- v. Retired Engineers will be required to obtain a No-Dues Pending / No-Inquiry Pending Certificate from their Organisation/Competent authority / Inquiry department.
- vi. Retired Engineer will be given exemption from submitting annual Turnover certificate, balance sheet certified by the Chartered Account, Solvency Certificate, Details of the Machinery and Equipment's, Details of works done as well as works in hand. This exemption will be available for 10 years from the date of registration.
- vii. In order to ensure the continuous benefits of technical knowledge and administrative experience of the engineers who have retired from the government service, the condition of renewal of registration after 3 years is relaxed. As per the B.M.C.'s prevalent rules of registration of contractors-

2016, period of renewal of registration is 5 years. Hence the condition of renewal of registration in B.M.C. for engineers retired from B.M.C. and Govt./Semi-Govt. services after 5 years is relaxed.

- viii. Retired Registered Civil Engineers Contractors are being exempted from the Income Registration Certificate required for furniture and similar works also they shall be eligible to get the works pertaining to natural calamities and pandemic situations.
- ix. These exemptions are available to Retired Engineers if they apply within 5 years after retirement / resignation.

## **2. Validity :-**

The registration of Retired Engineers- Contractors will be valid for a period of 10 years from the date of granting the registration, provided the firm is not deregistered or the conditions under which the registration is granted are unchanged.

## **3. Upgradation and Renewal :-**

Upgradation or renewal of registration for retired Engineers – contractor is not applicable.

All other conditions of registration as mentioned in the “Rules Governing Registration of contractors for Civil and Mechanical & Electrical Engineering works-2016” will be applicable for Registration of Engineers retired from B.M.C. and other Govt./Semi- Govt. Services.
